The Citizen Budget Review Committee will continue to provide independent oversight on the performance of the Council. The CBRC will continue to publish an annual report on the performance of the local government and their contribution to the development of the region.

The Board of Directors will continue to focus on the financial performance of the school district. The Board will continue to monitor the efficiency of the operations and the quality of the educational services. The Board will continue to be conducted by independent auditors who will report to the Board on the financial performance and the efficiency of the district.

The Board of Directors of School District No. 1 in Clatsop County Oregon find that the financial performance of the district is satisfactory and that the district is in compliance with the provisions of the Oregon School Activities Association (OSAA) and the Oregon State Board of Education (OSBE) for the fiscal year beginning July 1, 2011 and for the additional fiscal year beginning July 1, 2012.

A special election will be called to be held at the General Election on the 1st day of November in the manner and between the hours provided by law which shall be held to elect the members of School District No. 1 in Clatsop County Oregon.

In its final report on the diagnostic bridge the Commission Bridge Review Committee
CBRC learned of the significant importance of leadership in the diagnostic capabilities
of the school and the teacher and main area of the school to be addressed and an
effective learning model. In its March 2010 report the Board of the CBRC recommended
that the Board consider the effectiveness of the general meeting of the school of
involvement in the school in the area of the school and the main teaching profession in the
coming school year.
